

## RECAP OF THE 1978 BIGHORN SHEEP HUNT

The 1978 Arizona Desert Bighorn Sheep Hunt was a whopping success at 83% and produced a quality harvest with the average of all trophies scoring 155 3/8 Boone & Crockett points.

The largest trophy scored 183 1/8 pts. taken by James McCasland in the West Kofas. Thirty nine rams were harvested in total. The following are facts of interest.

- -twenty four rams were estimated to be 8 years old or older.
- -only ten rams were less than seven years old.
- —largest ram estimated at 12 years.

- -six rams scored over 170 B&C points (Boone & Crockett minimum
- -West Kofa ram (45A) scoring 183 points is best trophy taken in that unit since 1965, and is the 3rd best out of that unit.
- -three rams taken in the Catalinas (33) qualify for Boone & Crockett recognition. All scoring over 170 points.
- -Castledome (45C) ram scoring 176 points is largest recorded trophy ever taken in that unit.
- -Harquahala mountains (44A), hunted for the very first time, produced a-nice trophy at 163 points.
- -Husband and wife team, Ernest and Winifred Layman, first to ever

The above chart reflects some of the basic statistics concerning the 1978 Arizona Desert Bighorn sheep hunt. The following observations may be of interest

The Drawing - There were 1842 Total applicants; 501 were nonresidents. Only 1644 applicants elected to make a second choice.

Permits Issues — Out of the 52 permits issued, 38 hunters were lucky enough to draw their first choice hunt unit. Fourteen hunters, or 27% of the total number, drew their second choice hunt area.

The Hunt - The most disappointing statistic of all is that only 48 hunters went afield out of 52 permit holders. A total of 4 permits went unused, which represents over 7% of the total number of permits. It was determined that at least two hunters, out of the four, obtained permits by making multiple applications. In any case, the Game & Fish Department should adopt some reasonable and workable "alternate permit system" to preclude the future loss of unused permits. There are hundreds of hopeful sheep hunters who have applied unsuccessfully for over twenty years; and we let four priceless sheep hunting opportunities go down the well.

## Society Receives Tax Exempt Status; **Donations Are Now Fully Deductible**

The Society has finally received its tax exempt status which means that ALL DONATIONS ARE DEDUCTIBLE FROM YOUR INCOME TAX, as specified under Section 501(C)(3) of the Internal Revenue Code. The I.R.S. authorization further states that "Bequests, legacies, devises, transfers or gifts . . . are deductible for Federal estate and gifttax purposes . . . '

Receipts are issued for all monies received which will document your contributions for tax purposes. Although our annual dues are only five dollars, we encourage each of you to

send whatever you can afford.

Remember, the Sheep Society is the number one workhorse here in Arizona in promoting the conservation and wise management of desert bighorns. In the last 10 year period, we have developed over 60 major waterhole developments in conjunction with the Arizona Game and Fish Department.

Next to the loss of sheep habitat due to the encroachment of civilization, an uncontrolled and exploding population of burros poses the most serious threat to desert sheep. The two-legged Jackasses that defend the uncontrolled proliferation of burros are more insidious than the burros themselves. These same type of people have also launched a campaign to "save the desert sheep" by harassing properly licensed sheep hunters during the hunt and in the field. Burros have the potential of eliminating entire sheep herds, whereas the selective harvest of mature rams has absolutely no harmful effect on the sheep populations.

The Sheep Society fights this kind of ignorance and says that conservation means getting off your "ASS" and making a positive contribution to the management of our wildlife. WE HAVE THE PERSEVERANCE AND MUSCLE TO WAGE THE WAR; WE NEED YOUR FINANCIAL SUP-

The 1978 Sheep Hunt was the second best ever recorded in terms of success ratio and overall quality.

The proposed site improvement has been named "Eagle Scout Tank" after a group of Eagle Scouts who first discovered the pothole under the leadership of their number one big bird — Dean Bowdoin. Two large scale dams will be constructed which will require a work force of 50 to 75 men.

### Who Are Animals' Real Friends?

The situation in Colorado, Utah and Wyoming is this: Bitter winds and record snowfalls (40 inches in places) are keeping deer and elk herds from their food. In desperation, the animals have roamed hundreds of miles further than they have to in a normal winter to find nourishment. Last year's fawn are starving to death at what officials describe as "an alarming rate." Bighorn sheep have taken to raiding farmers' stocks.

Those animals too weak to forage simply lie down and die, their bloated appearance a grotesque conrast to what they looked like in health. Motorists are getting perturbed at hitting animals that have staggered onto roadways.

Some of the weakened animals that don't drop dead or get hit by cars are being chased by roaming domestic dogs. They die of exhaustion. Colorado expects to lose 35-50,000 deer and 20,000 elk before the thaw.

A lot of money is needed to feed these animals. Hay, alfalfa and a special diet for the sensitive digestive tracts of deer needs to be flown to the animals by helicopter. Exasperated biologists are pleading to lawmakers for money to feed the critters. But the bureaucratic wheels are grinding as if they are square.

Now my question to you and anyone else who will listen is: Where are the people who preach their deep concern for wildlife through their opposition to sport hunting?

Where is Cleveland Amory and his fund for Animals? Where is Alice Herrington and her Friends and Animals? Where is Sandy Rowland and the Humane Society of the U.S.?

I'll tell you where. They are in their offices opening envelopes full of money they talked out of their emotional followers. They are putting that money into advertising campaigns and administrative salaries. They aren't putting a seed of alfalfa in any starving animal's mouth, I can assure you of that.

You know what the animals have to depend on right now? A beer company, a number of whose chief officers are sport hunters. Anheuser Busch is donating \$100,000 to feed these starving creatures because nature has dealt them a blow infinitely more cruel than any hunting season.

Maybe the animals should be ignored. Maybe we should just let nature take its course. But then we would have to write off a lot of animals that development will make extinct, animals that just couldn't make it on their own after bulldozers chase them from their homes — animals like peregrine falcons, wild turkeys, bald eagles, deer and canvasback ducks. The list could go on.

So it would seem that helping animals in time of dire need is the "humane" thing to do.

But the "humane" groups aren't doing any of the real work. The workers who now are risking life and limb in the Western states to deliver food to the starving animals are being paid with funds from (hold onto your hats, sports fans) the sale of hunting licenses and taxes on hunting equipment. No money comes from income taxes. And certainly none comes from the zealots who would stop all hunting.

You want to talk to me about stopping sport hunting? Fine. But first give me the name of a group other than hunters concerned enough to put up the money to help the animals in times like this.

Otherwise, my friends, tell it to the marines.
